

<p><b>Ligation and Recutting (Terminal Integrity)</b>            After a 10-fold over-digestion of Lambda DNA with Bpml, &gt;95% of the DNA fragments can be ligated with T4 DNA ligase in 16 hours at 16°C. Of these ligated fragments, ~75% can be recut with Bpml.</p>	Pass
<p><b>Non-Specific DNase Activity (16 hour)</b>            A 50 µl reaction in NEBuffer 3.1 containing 1 µg of Lambda DNA and a minimum of 2 Units of Bpml incubated for 16 hours at 37°C results in a DNA pattern free of detectable nuclease degradation as determined by agarose gel electrophoresis. NOTE: although no nuclease degradation is detected under these conditions, extended incubations and/or high concentrations of this enzyme may result in star activity.
